Legislative Changes

Security Fencing and other measures

The Architectural Committee (AC) has reviewed the legislation and makes the following recommendations:

NEW SECURITY MEASURES POLICY

During the recent 87TH State Legislative Session, which was held last summer, new statutory laws were passed that affect the governance of Property Owners Associations (POAs) that are to be adopted by University Oaks Civic Club. One of them is the new Security Measures Policy. This policy stipulates that property owners cannot be prohibited to install security devices such as motion detectors, cameras and perimeter security fencing. Our Attorneys forwarded a draft proposed policy for the purpose of the University Oaks Civic Club (UOCC) to set standards for security fencing. Pursuant to review of the Security Measures Policy proposed by our Attorneys, the Architecture Committee (AC) offer the following for your review, consideration and input in reporting this during the Wednesday, November 10, 2021, Open Board Meeting:

Part 3, b. Type of Security Measure Fencing

- Materials can be either steel, wrought iron or aluminum. It states wrought iron in the last sentence of this paragraph. It states 8' in height. The AC recommend 5' ht. on N. MacGregor Way and 4' on all other streets. Comments during the October 13th meeting suggested allowing wood pickets.
- (v) Decorative elements or embellishments are prohibited. Comments suggested artistic elements be allowed, as exists in UO today.
- (iv) Color to be black.

- (x) Prohibited materials are stated.
- (xi) No vines or vegetation shall be allowed.

Part 4. The AC recommends that Security Measures stated, such as Burglar Bars, Security Screens, and Front Door Entry Door Entryway Enclosures, be deleted.

An additional comment that was made during the October 13th meeting, was to advocate to the community that it maintain its historic character of no fencing being allowed in the front of all lots.

The AC found the remainder of the Policy acceptable. The Attorneys have advised getting this Policy voted upon in the earliest properly scheduled Open Board Meeting.
