Committee Status Reports:

1. Treasury Update:

- a. Prepared to mail out 2022 dues that are still outstanding (~16k)
- b. Mailbox expense has increased and will be the only unexpected expense for November 2022.
- c. The immediate reason for the operational deficit is the addition of the property management company.
- d. The largest expense is security.
- e. The Board is working to correct the deficit and will provide thoughts on how to take action.
- f. Proposal to accept as paid and work to reconcile internally dues that were received by Chase (Zelle) and due to a technical issue have not yet been received by UOaks.
